What is a family office?

The notion of family office includes various forms of solving relational (family) and business (office) matters. Such matters include: preservation of family capital; increasing the efficiency of business and investment; transferring wealth as inheritance; solving family conflict; establishing a personal infrastructure.

A family office in Latvia

Family offices in Latvia may be established as limited liability companies (SIA) or joint-stock companies (AS). A company's profits are taxed at 15%, one of the lowest corporate income tax rate in Europe. If a family office is simultaneously a holding company, income from sale of capital and stocks and dividends (unless they match a list of tax haven jurisdictions) is not taxed, and some duties and fees are forgone as well. The state does not regulate the operations of an individual or multi-family office unless it engages in banking or management of third party assets. If a family office is a separate entity from the business of its owners and acts as a consultant for them and their companies, the liability of board members is regulated by the Commercial Law and common law regulations of the Civil Law applicable to compensation of damages, and may be limited by reservations stipulated in agreements and by insurance of the liability of officials.

How does it work?
